Surrogate Fee - Gestational Fee <i>*\$25,000-\$32,000 first-time / \$32,000-\$38,000 experienced</i>	\$25,000-\$32,000	Surrogate Expense - Travel Companion for First Transfer <i>*Flight and food reimbursed only.</i>	\$750-\$1,500
